## AUTHORIZATION TO REPAIR

MILSTEAD AUTOMOTIVE EMPLOYEES MAY OPERATE THE VEHICLE FOR PURPOSE OF TESTING, INSPECTION, OR DELIVERY AT MY RISK. MILSTEAD AUTOMOTIVE WILL NOT BE RESPONSIBLE FOR LOSS OR DAMAGE TO VEHICLE OR ARTICLES LEFT IN VEHICLE IN CASE OF FIRE, THEFT, ACCIDENT, DAMAGE FROM FREEZING DUE TO A LACK OF ANTIFREEZE, OR ANY OTHER CAUSE BEYOND OUR CONTROL, NOR SHALL MILSTEAD AUTOMOTIVE BE RESPONSIBLE FOR DELAYS CAUSED BY UNAVAILIBLTY OF PARTS OR DELAYS IN PARTS SHIPMENTS BY THE SUPPLIER OR TRANSPORTER. AN EXPRESS MECHANICS LIEN IS ACKNOWLEDGEED ON THE VEHICLE TO SECURE PAYMENT FOR SUCH REPAIRS AND MATERILS USED IN COMPLETING THE WORK. STANDARD TERMS ON APPROVED CHARGES ACCOUNTS ARE FOR STATEMENT BALANCE TO BE PAID IN FULL BY THE 10<sup>TH</sup> OF THE MONTH FOLLOWING PURCHASES. SHOULD ACCOUNT NOT BE PAID IN ACCOEDANCE WITH THIS AGREEMENT, INTEREST SHALL ACCRUE AT THE HIGHEST RATE ALLOWED BY LAW. I ALSO AGREE TO PAY ANY RESPONSILBE ATTORNEY FEES. MY SIGNATURE IS EVIDENCE OF MY FULL UNDERSTANDING AND ACKNOWLEDGMENT OF THE CONDITIONS COVERED HEREIN. PAYABLE IN SPRING, MONTGOMERY COUNTY, TEXAS.
